ASSIGNMENT AND INVENTOR DECLARATION

UNITED STATES PATENT APPLICATION

Riera de Caldes, Palau Solita I Plegamans (Barcelona) 08184 Spain, (hereinafter the "Assignor") have invented certain new and useful improvements in INFANT CHAIRS (hereinafter the "Invention") for which I have made an application for design patent of the United States, filed July 16, 2014, and identified as application no. 29/496,703 (hereinafter the "Application").

WHEREAS, JANE, S.A. of Mercaders, 34 - Pol. Ind. Riera de Caldes, Palau Solita I Plegamans (Barcelona) 08184 Spain, a corporation organized under the laws of Spain, (hereinafter the "Assignee") is desirous of acquiring the entire right, title and interest to any United States patent that may be granted for the Invention and based upon the Application and the entire right, title and interest to make, use and sell the Invention within the United States of America and its territorial possessions.

NOW, WHEREAS AND IN ACCORDANCE WITH THE PROVISIONS SET FORTH HEREIN, that for and in consideration of a sum of Ten Euros (EUR), in hand paid to me, and other good and valuable consideration, the receipt of which I hereby acknowledge, I do hereby assign, sell and transfer to the Assignee the entire right, title and interest in and to the Invention and Application for patent of the United States, and in and to all nonprovisional applications for patent of the United States claiming priority to the Application, such as continuing applications including divisional applications, and in and to any patent of the United States and all reissues and extensions thereof that may be granted, together with the right to extend the protection for the patent to the various territorial possessions now owned or which may be hereafter acquired by the United States of America, together with all rights of priority granted by local laws and treaties including any international convention, for the protection of industrial property, all rights conveyed herein to be held and enjoyed by the Assignee for its own use and behoof, and for the use and behoof of its successors or assigns, to the full end of the term for

which any patent or industrial property right for the Invention is enforceable, as fully and entirely as the same would have been held and enjoyed by me if this assignment had not been made. I do hereby request and authorize that any and all patent and any and all industrial property right, when granted, be issued in accordance with this assignment to the Assignee.

WHEREAS, in further consideration of the sum of Ten Euros (EUR), and the other good and valuable consideration, to me paid, I covenant and agree with the Assignee that it has a full and unencumbered title to the Invention and Application hereby assigned, which title I warrant unto the Assignee, and I further agree that I will, without demanding any further consideration therefor, at the request but at the expense of the Assignee, do all lawful and just acts, including the execution and acknowledgment of instruments, furnishing of information, and giving of testimony that may be or become necessary for obtaining, sustaining, or reissuing United States, and for maintaining and perfecting the Assignee's right to the Invention and any patent and industrial property right granted for the Invention, such as in cases of interference, derivation, post-grant review proceeding before the United States Patent and Trademark Office, and litigation.




