AND, WE HEREBY AUTHORIZE AND REQUEST the Commissioner of Patents and Trademarks to issue all Letters Patents on said invention or resulting therefrom to said Assignee, as assignees of our entire right, title and interest, and we covenant that we have full right so to do.
