and including the right to apply for any Letters Patent in the United States of America and in all foreign countries on said invention and including the right to claim the priority of the date of filing in the United States and any Letters Patent that may issue thereon, or therefore, in the United States and foreign countries and all reissues, extensions, renewals, divisions and continuations thereof, to the full end of the term or terms for which said Letters Patent may be issued, to be held and enjoyed by the said Assignee, its successors and assigns the same as it would have been held and enjoyed by Alliance Optotek Co., Ltd., if this assignment and sale had not been made.

AND, Alliance Optotek Co., Ltd., hereby authorizes and requests the Commissioner of Patents and Trademarks to issue all such Letters Patents to the said Assignee, in accordance with this instrument of assignment.


