ARTICLES OF MERGER

Pursuant to the provisions of RSMo. § 347.725, the undersigned entities hereby certify the following:

1. That the constituent entities are SEMCO Incorporated, a Missouri corporation, and SEMCO Merger, LLC, a Missouri limited liability company.
2. An Agreement and Plan of Merger has been authorized and approved by each of the constituent entities in accordance with Section 347.720, RSMo.
3. The effective time and date of the merger shall be as of 11:59 p.m. on September 30, 2010.
4. The name of the surviving entity is SEMCO Merger, LLC (the "Survivor").
5. The address of the registered office and the name of the registered agent at such office for the Survivor shall be 1000 Walnut Street, Suite 1400, Kansas City, Missouri 64106, and Spenserv, Inc.
6. Effective upon the effectiveness of the merger, Section 1 of the Articles of Organization of the Survivor are hereby amended to read as follows: "The name of the limited liability company is SEMCO LLC." As so amended, the organizational documents of the Survivor shall be the organizational documents of the surviving entity.
7. The executed Agreement and Plan of Merger is on file at the principal place of business of the surviving entity, which is located at 1800 East Pointe Drive, Columbia, Missouri 65201.
8. A copy of the Agreement and Plan of Merger will be furnished by the surviving or new entity, on request and without cost, to any partner, shareholder, member, or their equivalent of any entity that is a party to the merger.
