PATENT ASSIGNMENT AGREEMENT

This **PATENT ASSIGNMENT AGREEMENT** ("Assignment"), dated as of November 18, 2014, is made by **PAUL OBERLE**, a Missouri resident (hereinafter "Assignor") in favor of the Trustee of the **OBERLE FAMILY TRUST**, dated November 18, 2014, as may be amended, a trust formed under the laws of the State of Missouri (hereinafter "Assignee").

WHEREAS, Assignor is the sole owner of two United States issued patents, with patent numbers 8,277,477 and 8,241,316 (the "Patents");

WHEREAS, Assignor desires to transfer to Assignee, and Assignee desires to accept from Assignor, all of its worldwide right, title, and interest in and to the Patents;

NOW, THEREFORE, for good and valuable consideration, the sufficiency of which is hereby acknowledged, the Parties hereto agree as follows:

1. **Assignment.** Assignor hereby conveys, transfers, and assigns to Assignee, and Assignee hereby accepts, all of Assignor's worldwide right, title, and interest in and to the Patents, together with: (i) All issuances, divisions, continuations, continuations-in-part, reissues, extensions, reexaminations and renewals thereof; (ii) all rights of any kind whatsoever of Assignor accruing under any of the foregoing provided by applicable law of any jurisdiction; (iii) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and (iv) any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, misappropriation, violation, misuse, breach or default, with the right but not the obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.


2. **Recordation and Further Actions.** Assignor hereby authorizes the Commissioner for Patents in the United States Patent and Trademark Office, and the officials of corresponding entities or agencies in any applicable jurisdiction, to record and register this Assignment upon request by Assignee. Following the date hereof, Assignor shall take such steps and actions, and provide such cooperation and assistance to Assignee as may be reasonably necessary to effect, evidence, or perfect the assignment of Patents to Assignee or any assignee or successor thereto.

3. **Successors, Assigns, and Governing Law.** This Assignment shall be binding up and shall inure to the benefit of the parties hereto and their respective successors and assigns. This Assignment and any claim, controversy, dispute, or cause of action (whether in contract, tort, or otherwise) based upon, arising out of, or relating to this Assignment shall be governed by, and construed in accordance with, the laws of the State of Missouri, without giving effect to any choice or conflict of law provision or rule.


