(i) any and all claims and demands that ASSICNORS may have against any firm, person or corporation relating to the PATENT APPLICATION including but not limited to, any claim of infringement or claim of provisional rights, whether heretofore or hereafter accrued, together with the right to retain for ASSIGNEE any and all sums that
