IN WITNESS WHEREOF, AT&T Properties has caused this Recordable Patent Assignment to be executed by its duly authorized representative.

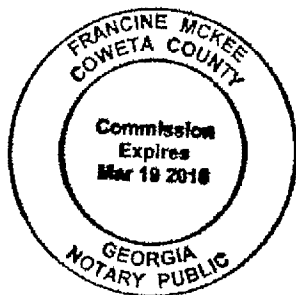
