AND I/WE HEREBY further covenant and agree that I/We will communicate to the said **Edwards Japan Limited**, its successors, legal representatives and assigns, any facts known to me/us respecting said invention and said improvements, and testify in any legal proceeding, sign all lawful papers, execute all continuing prosecution, divisional, continuing, reexamination and reissue applications, make all rightful oaths, and generally do everything possible to aid the said **Edwards Japan Limited**, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said inventions and improvements in all countries.
