Patent Assignment Agreement

This Patent Assignment Agreement is entered into by and between

Chemilia AB, 556617-4800, Forskargatan 20 H, 151 36 Södertälje, SWEDEN (*"the Assignor"*)

and

Noviga Research AB, 556725-0450, Vårvägen 3, 146 52 Tullinge, SWEDEN [*"the Assignee"*].

The Assignor and the Assignee are referred hereafter in this Patent Assignment Agreement to as *"the Parties"*.

1 Background

- 1.1 The Assignor has decided to assign certain intellectual property rights, including patent rights and know how, to the Assignee. The Parties have therefore entered into this Patent Assignment Agreement (*"the Agreement"*).

2 Assignment

- 2.1 As per 29 August 2014 (*"the Effective Date"*), the Assignor assigns to the Assignee, for the remuneration of 1 (one) Swedish krona, all and any of its rights to the patent rights listed in Appendix 1, including any related know how (*"the Patent Rights"*).
- 2.2 The Assignee receives full and exclusive rights to the Patent Rights including the right to file patent applications, continuation applications, continuation-in-part applications, divisional applications, reissue applications, extension applications and any and all patents that may be granted for the relevant inventions, including supplementary protection certificates and patent term extensions, in all countries, also including the right to claim priority under the Paris Convention for the Protection of Industrial Property.
- 2.3 The assignment includes know how, such as research data, as well as any and all proprietary documentation relating to the Patents Rights.

3 Costs and Transfer

- 3.1 The Assignee shall, from the Effective Date, be responsible for all and any costs connected with the Patents Rights, such as prosecution and maintenance, including all and any transfer costs, including the drafting and execution of this Agreement and the recording of the transfer as outlined in Section 3.2.

Furthermore the Assignee shall be responsible for any costs connected with the Patent Rights which have arisen before the Effective Date but which have not yet been invoiced to Assignor as per 30 September 2014.

- 3.2 The Assignee shall be responsible for the recording of the assignment and transfer of the Patents Rights with any relevant patent authorities world-wide, in order to duly register the transfer, and the Assignee shall pay all and any costs related to the recording and transfer of the assignment.
- 3.3 The Assignor undertake to sign, execute and deliver, at any time and as required by national laws, free of charge, any and all documents, forms and authorizations necessary for the grant of any of the Patent Rights as well as any such documents that may be necessary for enforcement of all future patents related to the Patent Rights, in all countries concerned, and to provide all other reasonable assistance, free of charge, as is reasonable requested by Assignee and deemed essential to Assignee's full protection and title in and to the Patent Rights.

4 Warranties

- 4.1 The Assignor confirms (i) that the Assignor is the sole owner of the Patent Rights and (ii) that the inventors have duly assigned all of their relevant rights to the Assignor and (iii) that the Assignor therefore is capable and entitled to assign the Patent Rights to the Assignee according to this Agreement.
- 4.2 The Assignee accepts and confirms that the Patent Rights as such are assigned "as is" and that no warranties and representations exist, including any issues related to the validity or status of the Patent Rights or the possibility to commercialize the Patent Rights.

5 Entire Agreement

- 5.1 This Agreement constitutes the entire agreement between the Parties relating to the Patent Rights. The contents of this Agreement supersede all previous written or oral commitments and undertakings between the Parties.

6 Governing Law

- 6.1 This Agreement is governed by the laws of Sweden.

This Agreement has been duly executed in two (2) original copies, of which the Parties have taken one each.
