Assignment of Invention

BOUXSEIN, of 3259 West Grand Avenue, Englewood, Colorado 80110 U.S.A., have invented certain new and useful improvements in an invention entitled UNDERWATER PLATFORM WITH LIDAR AND RELATED METHODS, for which an application for Letters Patent of the United States has been filed on April 4, 2014, and which may be identified in the United States Patent Office by Application No. 14/245,522.
