**ASSIGNMENT DOCUMENT**

United States and all foreign countries on said Inventions; and in and to all rights of priority resulting from the filing of patent applications describing the Invention.


ASSIGNORS hereby authorize and request the Director of the U.S. Patent and Trademark office and all foreign Patent Offices to issue Patents for the subject matter assigned herein to ASSIGNEE for the sole and exclusive benefit of ASSIGNEE to the full end of the term for which said Patent may be granted as fully and entirely as the same would have been held by ASSIGNORS had this assignment and sale not been made.

In the event ASSIGNEE is unable, after reasonable effort, to secure ASSIGNORS'S signatures on any documents relating to protection or maintenance of the Inventions or applications describing the Inventions, whether because of ASSIGNORS' physical or mental incapacity or for any other reason, ASSIGNORS hereby irrevocably designate and appoint ASSIGNEE and its duly authorized officers and agents as their agent and attorney-in-fact, to act for and on their behalf to execute and file any application or applications and to do all other lawfully permitted acts to further the prosecution, issuance, and maintenance of the Inventions or improvements to the Inventions with the same legal force and effect as if personally executed by ASSIGNORS.

ASSIGNORS hereby covenant with ASSIGNEE, its successors, assigns and legal representatives that no assignment, grant, mortgage, license or other agreement affecting the right to the Inventions conveyed herein has been made to another by the undersigned and that the full right to convey as herein expressed is possessed by ASSIGNORS free and clear of all liens, pledges, charges and encumbrances. In cases where such information is missing ASSIGNORS grant ASSIGNEE and agents or representatives of ASSIGNEE the right to modify this document to indicate the filing date and serial number assigned to the U.S. Patent Application(s) this document relates to. This Assignment may be executed in counterparts, each of which shall be deemed an original.
