## PATENT ASSIGNMENT

This Patent Assignment is entered into by and between Premier Systems USA, Inc., a California corporation having its principal place of business at 16291 Gothard Street, Huntington Beach, CA 92647 (hereinafter referred to as “*Assignor*”), and olloclip, LLC, a Delaware limited liability company having its principal place of business at 16291 Gothard Street, Huntington Beach, CA 92647 (hereinafter referred to as “*Assignee*”).

WHEREAS, Assignor has obtained issued design and utility patents in the United States of America and in other countries, and has filed design and utility patent applications in the United States Patent and Trademark Office and in the patent offices of other countries (for convenience, all issued patents obtained by Assignor worldwide and all patent applications filed by Assignor worldwide, including but not limited to the issued patents and patent applications identified in Schedules 3.4(a) and 3.4(b) attached hereto, are hereinafter referred to as the “*Assigned Patent Rights*”);

WHEREAS, the services of certain inventors employed by Assignor were loaned to Assignee from November 1, 2013 to December 31, 2013 in anticipation of the contribution of assets from Assignor to Assignee, during which time such inventors continued to have an obligation to assign their inventions to Assignor, but Assignor permitted certain design and utility patent applications to be assigned by such inventors directly to Assignee in anticipation of such contribution of assets from Assignor to Assignee;

WHEREAS, as of January 1, 2014, certain inventors of Assignor were discharged from Assignor and employed by Assignee, at which time such inventors had an obligation to assign their inventions to Assignee, and Assignor agreed to and therefore had an obligation to assign all of its intellectual property to Assignee; and

WHEREAS, for good and valuable consideration, the receipt of which is hereby acknowledged, the Assignor has sold, transferred, assigned, and set over, and desires to sell, transfer, assign, and set over unto the Assignee all rights, title, and interests of the Assignor in, to, and under the Assigned Patent Rights;

1. NOW, THEREFORE, Assignor confirms that it has sold, assigned, transferred, and set over, and does hereby sell, assign, transfer, and set over unto the Assignee, its successors and assigns, the entire right, title, and interest in the United States and throughout the world (with priority rights) in, to, and under the patent applications and issued patents identified in Schedule 3.4(a), and in, to, and under any provisional applications relating thereto, and all nonprovisional applications claiming priority thereto, including, all divisionals, continuations, continuations-in-part, reissues, and reexaminations thereof, and all Letters Patent of the United States which may have been and may be granted thereon, and all reissues and extensions thereof, and all rights of priority under International Conventions and any related Letters Patent which may hereafter be granted or filed in any country or countries foreign to the United States, all extensions, renewals and reissues thereof, together with all claims for damages, in the past, present, and future, by reason of any infringement of any of the patent applications and issued patents identified in Schedule 3.4(a) and all nonprovisional applications claiming priority thereto, with the right to sue for and collect the same.

2. Assignor further confirms that to the extent it owns any interest in any other patent applications or issued patents (aside from those specified in Section 1), including but not limited to the patent applications and issued patents listed in Schedule 3.4(b), Assignor has sold, assigned, transferred, and set over, and does hereby sell, assign, transfer, and set over unto the Assignee, its successors and assigns, the entire right, title, and interest in the United States and throughout the world (with priority rights) that Assignor has possessed or does now possess in, to, and under such other

patent application or issued patents, including but not limited to the patent applications and issued patents identified in Schedule 3.4(b), and in, to, and under any provisional applications relating thereto, and all nonprovisional applications claiming priority thereto, including, all divisionals, continuations, continuations-in-part, reissues, and reexaminations thereof, and all Letters Patent of the United States which may have been and may be granted thereon, and all reissues and extensions thereof, and all rights of priority under International Conventions and any related Letters Patent which may hereafter be granted or filed in any country or countries foreign to the United States, all extensions, renewals and reissues thereof, together with all claims for damages, in the past, present, and future, by reason of any infringement of any other patent application or issued patents, including but not limited to any of the patent applications and issued patents identified in Schedule 3.4(b), and all nonprovisional applications claiming priority thereto, with the right to sue for and collect the same.



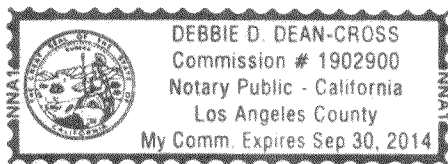

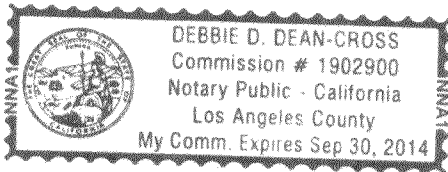
