ASSIGNMENT

- (f) any and all applications for Letters Patent on the INVENTION that may hereafter be filed in any and all countries foreign to the United States of America, together with all rights to file and to claim priority in connection with foreign-filed applications;
- (g) any and all refilings, divisions, and continuations of the foreign-filed applications;


- (b) any and all Letters Patent of countries foreign to the United States of America that may issue from the foreign-filed applications, refilings, divisions, and continuations; and
- (i) any and all extension of, and additions to, said Letters Patent of countries foreign to the United States of America.

AND ASSIGNOR, their successors and assigns, hereby agrees to execute without further consideration any further lawful documents and any further assurances, and any divisional, continuing, reissue, or other applications for patents of any country, that may be deemed necessary by the ASSIGNEE fully to secure to the ASSIGNEE their interest as aforesaid in and to the INVENTION or any part thereof, and in and to said several patents or any of them;

AND ASSIGNOR hereby covenants and agrees with the ASSIGNEE, their successors and assigns, that ASSIGNOR has granted no right or license to make, use, or sell the INVENTION, to anyone except the ASSIGNEE, that prior to the execution of this assignment, ASSIGNOR'S right, title and interest in the INVENTION have not been otherwise encumbered, and that ASSIGNOR has not executed and will not execute any instrument in conflict herewith.
