ASSIGNOR hereby sells, assigns, transfers, conveys and delivers to ASSIGNEE, its successors, legal representatives and assigns, all rights of enforcement, all claims for damages and all remedies arising out of, relating to or resulting from the Patent Items or any violation(s) thereof, whether accrued prior to the date of this Patent Assignment or hereafter, including but not limited to the right to sue for, seek, collect, recover and retain damages and any other relief arising out of or resulting from any past, present or future infringement or violation of any of the Patent Items, and all other rights, including common law rights, that ASSIGNOR may have relating to the Patent Items, including but not limited to any ongoing or prospective royalties to which ASSIGNOR may be entitled, or that ASSIGNOR may collect for any infringements of any of the Patent Items or from any settlement or agreement related to the Patent Items arising before or after the date of this Patent Agreement, such rights to be held and enjoyed by ASSIGNEE, its successors, legal representatives and assigns, as fully and entirely as the same would have been held and enjoyed by ASSIGNOR if this Patent Assignment had not been made.



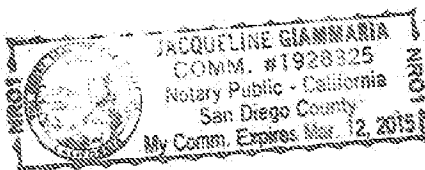


