AND I/WE hereby covenant for myself / ourselves and my / our legal representatives, and agree with said ASSIGNEE, its successors and assigns, I / we have granted no right or license to make, use, sell or offer to sell said Invention, to anyone except said ASSIGNEE, that prior to the execution of this deed, our right, title and interest in said Invention had not

been otherwise encumbered, and I / we have not and will not execute any instrument in conflict therewith;

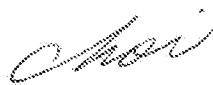

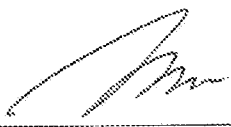
