ASSIGNMENT OF PATENT RIGHTS

THIS ASSIGNMENT is between and among Adams Bank and Trust, a banking institution authorized to and doing business in the State of Colorado whose address is 7800 South Highway 287, Fort Collins, Colorado 80525 (“Assignor”) and KLLL, LLC, a Colorado Limited Liability Company whose address is 405 Mason Court, Suite 117, Fort Collins, Colorado 80524 (“Assignee”).

WHEREAS, Agrihouse, Inc., through Richard J. Stoner, executed promissory notes on March 3, 2006 and December 14, 2009 in favor of Assignor.

WHEREAS, the promissory note executed on December 14, 2009 was secured by personal property described in a commercial security agreement of the same date in which Agrihouse, Inc. pledged all inventory, chattel paper, accounts, equipment and general intangibles then owned or after acquired and it was further secured by all inventory, chattel paper, accounts, equipment and general intangibles then owned or after acquired of Richard J. Stoner and Joyce K. Stoner.

WHEREAS, at the time of executing the promissory note and securing it with all intellectual property, Agrihouse, Inc. or Richard J. Stoner had ownership or assignment rights in US Patent Numbers 6167652, 6807770, 5726123, 6193988 and US Patent Application 11/517,035 (“Inventions”);

WHEREAS, on May 27, 2011, Richard J. Stoner, on behalf of Agrihouse, Inc., filed a voluntary petition for bankruptcy in the United States Bankruptcy Court, District of Colorado, number 11-22734-HRT;

WHEREAS, on August 10, 2011, the United States Bankruptcy Court, District of Colorado in number 11-22734-HRT granted Assignor relief from the automatic stay;

WHEREAS, on September 22, 2011, Agrihouse, Inc. and Richard J. Stoner, for good and valuable consideration, voluntarily surrendered, sold, granted, transferred, authorized application for, agreed to support, and assigned to Assignor the entire right, title, and interest in and to all collateral securing the promissory notes described above; AND,

WHEREAS, on March 2, 2012, Assignee and Assignor entered into an agreement to purchase all personal property, intellectual property, and rights transferred from Agrihouse, Inc. and Richard J. Stoner;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, each of the undersigned hereby agree as follows:

1. Assignor states that, to the best of its knowledge:
 - a. it has the authority to assign all right, title, and interest in and to the Inventions;

b. it has conveyed no right, title, or interest in the Inventions to any party other than Assignee;

c. at the time of signing of this Assignment, it neither knows nor has reason to know of any outstanding right, title, or interest in the Inventions inconsistent with a full assignment of rights to Assignee.

2. Assignor, for good and valuable consideration, hereby sells, grants, transfers, authorizes application for, agrees to support, and assigns to Assignee the entire right, title, and interest in and to the Inventions, including, but not limited to:

a. all such worldwide rights to make, use, offer-for-sale and sell the Inventions;

b. the above-identified patent application and to any division, substitution, continuation, or continuation-in-part, of such application, all patents which may be granted thereon, and all reissues, and extensions thereof;

c. the right to file applications for United States or foreign patents based upon the Invention, and to make a claim for any priority to which such applications are entitled, and to any division, substitution, continuation, or continuation-in-part, of such applications, all patents which may be granted thereon, and all reissues and extensions thereof;

d. all related rights involving the Inventions in any country such as utility-model registrations, inventor's certificates, and the like, and all rights, titles, and interests involving the Invention under any foreign government;

3. Assignor acknowledges that pursuant to the sale, grant, transfer, and assignment to Assignee of the entire right, title, and interest in and to the Invention, as provided in the above paragraphs, this assignment shall be complete as to all rights owned. As such, Assignor consents to a waiver of any and all access rights to any applications for United States or foreign patents relating to the Inventions, and including but not limited to the above-identified application, and to any division, substitution, continuation, or continuation-in-part, of such applications, all related access rights involving the Inventions in any country such as utility-model registrations, inventor's certificates and the like, and all access rights, titles, and interests involving the Invention under any foreign government, to the extent permissible.

4. Assignor further covenants and agrees that it will sign all lawful papers and consents, as well as aid the Assignee in petitioning waiver of access of Assignor to the United States or foreign patent offices of any and all applications for United States or foreign patents relating to the Invention, as provided above.

5. Assignor grants the firm of CR MILES P.C., or other designated agent, the power to insert on this Assignment any further identification which may be necessary or desirable in order to comply with the rules of the Patent Cooperation Treaty or the United States Patent Office or any foreign patent office for recordation of this document, including, but not limited to, inserting the application number, the execution date, or the filing date of the above-identified United States Patent Application based upon the Inventions.

6. This assignment shall be binding on all parties, their heirs, executors, administrators, successors, or assigns, and may be recorded in the United States Patent and Trademark Office or elsewhere. In the event any provision of this Agreement is found to be unenforceable or to be unreasonable in scope, such provision shall be modified only to the extent necessary to make it enforceable, and as so modified, this Agreement shall remain in full force and effect.

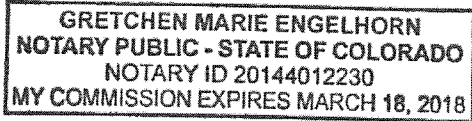

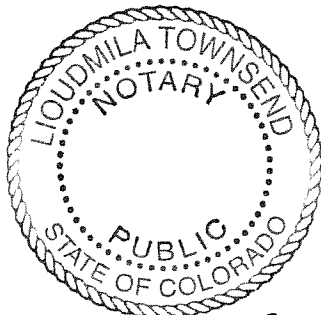
