ASSIGNMENT

This is an assignment of rights from John. P. Davies and Hein Tsoeng (Medard) Ng to Exelixis Plant Sciences, Inc., and from Exelixis Plant Sciences, Inc. to Agrigenetics, Inc.

WHEREAS, we, **John P. Davies** of Portland, Oregon and **Hein Tsoeng (Medard) Ng** of Charlottesville, Virginia, have previously entered into an agreement with Exelixis Plant Sciences, Inc. having a place of business at 16160 SW Upper Boones Ferry Road, Portland, Oregon, 97224, to assign all right, title and interest in and to any of all inventions made or conceived or reduced to practice during the course of employment with Exelixis Plant Sciences, Inc. (hereinafter "EPS"), and further agreed to execute additional assignment documents to assist EPS with respect to its proprietary rights, and wherein, during the course of employment with EPS, an invention entitled **GENERATION OF PLANTS WITH ALTERED OIL, PROTEIN, OR FIBER CONTENT**, for which the following patent applications have been filed:

PCT Patent Application No. PCT/US2007/087786, filed December 17, 2007;
U.S. Utility Patent Application No. 11/958,113, filed December 17, 2007; and
U.S. Utility Patent Application No. 12/831,097, filed July 6, 2010;

all of which are referred to hereafter as "the patent applications."

WHEREAS, EPS is desirous of assigning said right, title and interest in the patent applications to Agrigenetics, Inc., and whereas EPS has received good and valuable consideration for this assignment, the receipt and sufficiency whereof are hereby acknowledged.

WHEREAS, Agrigenetics, Inc., having a place of business at 9330 Zionsville Road, Indianapolis, Indiana 46268, is desirous of acquiring the entire right, title, and interest therein:

NOW, therefore, and in consideration of employment and compensation paid the inventors by EPS, and other good and valuable consideration, the receipt and sufficiency whereof are hereby acknowledged, we have assigned to EPS and EPS' legal representatives, successors and assigns, the entire right, title, and interest (a) in and to said patent applications and said invention; (b) in and to all rights to apply for foreign patents on said invention; (c) in and to any and all applications filed and any and all patents granted on said invention in the United States or any foreign country, including each and every application filed and each and every patent granted on any application

which is a division, substitution, continuation or nonprovisional 37 CFR 1.53(b) application of any of said applications; and (d) in and to each and every reissue or extension of any of said patents.





EPS hereby accepts the assignment of rights in this invention.

EPS hereby assigns to Agrigenetics, Inc. and Agrigenetics Inc.'s legal representatives, successors and assigns, all right, title, and interest that it now owns or shall hereafter acquire (a) in the patent applications; (b) to all rights to apply for foreign patents on the patent applications; (c) to any and all applications filed and any and all patents granted on the patent applications in the United States or any foreign country, including each and every application filed and each and every patent granted on any application which is a division, substitution, continuation or nonprovisional 37 CFR 1.53(b) application of any of said applications; and (d) to each and every reissue or extensions of any of said patents; and EPS hereby authorizes and requests the patent office to issue said patents to Agrigenetics, Inc. EPS agrees to execute such additional assignments and other writings and do such additional acts as may be necessary or desirable in order to perfect this grant to Agrigenetics, Inc.

EPS hereby authorizes Agrigenetics, Inc. or its legal representative to insert in this instrument the filing date and serial number of any said application or any other information that may be necessary or desirable in order to comply with the rules of any patent office for recordation of this document.





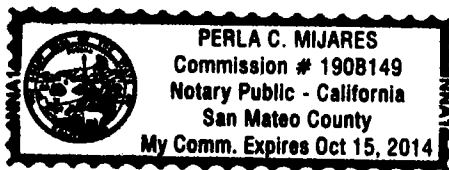
