**RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "Release"), dated as of December 1, 2014, is made by SunTrust Bank ("SunTrust"), as administrative agent ("Administrative Agent"), under the Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement).

WHEREAS, in connection with that certain Amended and Restated Revolving Credit and Term Loan Agreement dated as of July 8, 2013 (together with all amendments, supplements and addenda thereto, the "Credit Agreement"), by and among MedSolutions Holdings, Inc., a Delaware corporation (the "Borrower"), the several banks and other financial institutions and lenders from time to time party thereto (the "Lenders"), and SunTrust as Administrative Agent, the Lenders agreed to make certain advances of money and to extend certain financial accommodation to the Borrower;

WHEREAS, in connection with the Credit Agreement and pursuant to that certain Guaranty and Security Agreement dated as of April 22, 2011 (the "Guaranty and Security Agreement"), Premerus, Inc. (the "Grantor") was required to execute and deliver certain Patent Security Agreements and Trademark Security Agreement, each in favor of the Administrative Agent, which granted to Administrative Agent security interests in certain intellectual property owned by the Grantor, including the intellectual property listed on Annex I and Annex II attached hereto (the "Intellectual Property Collateral");

WHEREAS, the Patent Security Agreements were recorded in the USPTO on the dates and in the reel and frame numbers as set forth on Annex I hereto; and

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office (the "USPTO") on the date and in the reel and frame number as set forth on Annex II hereto.

NOW THEREFORE, Administrative Agent hereby releases, terminates, cancels and discharges, without representation, recourse or warranty whatsoever, all of its security interest in the Intellectual Property Collateral, whether granted pursuant to any agreement or document delivered in connection with the Guaranty and Security Agreement and Administrative Agent hereby reassigns any and all such right, title and interest (if any) that Administrative Agent may have in the Intellectual Property Collateral to the Grantor.


Administrative Agent agrees, at the Grantor's expense, to cooperate with the Grantor and to provide the Grantor with the information and additional authorization reasonably required or desirable to effect the release of the Administrative Agent's security interest in the released collateral described herein.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
