ASSIGNMENT

PARTIES:

- (1) **MAVO VOGGENREITER GMBH** with its registered address at Industriestrasse 9-10, 95336 Mainleus, Germany (hereinafter "MAVO")
- (2) **ELEMENT SIX LIMITED**, registered in Ireland under company number 365394, with its registered address at Shannon Airport, Shannon, Co Clare, Ireland (hereinafter "E6")

DEFINITIONS:

For the purposes of this Assignment:

"Agreement" shall mean the agreement dated 11th April 2011 defining a collaboration project between the Parties (hereinafter the "Collaboration Project"), and the ownership of inventions arising from the Collaboration Project.

"Application" shall mean, collectively and severally, the patent applications listed in the Schedule to this Assignment.

"Invention" shall mean the invention relating to the Application

WHEREAS:

- A. By virtue of the Agreement, any invention arising out of, from or in connection with the Collaboration Project shall belong to E6 and MAVO shall not acquire any title, interest or rights therein.
- B. The Invention is an invention arising out of, from or in connection with the Collaboration Project, and as such belongs to E6, and MAVO have no title, interest or rights therein.
- C. For the avoidance of doubt, and so as to confirm E6's legal title to the same, the Parties have agreed to execute this Assignment for the purpose of ensuring that all MAVO's rights in the Invention and the Application and all other intellectual property rights relating thereto are vested in E6.

IT IS AGREED THAT:

In consideration of the sum of \$1(one US dollar) paid by E6 to MAVO, the receipt of which is hereby acknowledged:


1. MAVO hereby confirms that in accordance with the Agreement all its property right title and interest in and to the Invention and the Application are vested in E6, and E6 accepts that this is the case; and for the avoidance of doubt, MAVO as necessary hereby assigns to E6 any remaining property right title and interest in and to the Invention and the Application, effective as of the date of the Invention (the "Effective Date"), and E6 hereby accepts the same. The Parties agree that the property right title and interest in and to the Invention and the Application that are vested in E6 or as necessary hereby assigned to E6 are for all relevant states including without limitation:
 - (a) the right to apply for and obtain patents in respect of the Invention in any country in the world;
 - (b) all right title and interest in the Application and all patent applications, patents and supplementary protection certificates which may now or at any time in the future derive or result or claim priority from the same or otherwise relate to the Invention, including any divisionals, continuations, reissues, reexamination certificates, extensions, renewals and registrations in relation to any thereof and all and any other rights in the Inventions comprised in any of the same (together referred to as the "Patent Rights");
 - (c) the benefit of all priority dates;
 - (d) the right to seek and obtain registrations in any country in the world in respect of any patent deriving from the Application or otherwise included in the Patent Rights;

- (e) the right to sue for and obtain injunctive relief, damages and all other relief in respect of any infringement or misuse (whether past present or future) of any of the Patent Rights or of the rights conferred by publication of any of the same.
2. MAVO hereby agrees to execute all such documents and do all such things as may be required by the law of any country in order to record the Application and any other Patent Rights in the name of E6.
3. This Assignment shall be governed by English law and the parties submit to the exclusive jurisdiction of the English Courts in respect of any dispute relating to this Assignment.
