I hereby authorize and request the United States Commissioner of Patents and Trademarks to issue any and all Letters Design Patent which may be granted upon any of said applications, to said ASSIGNEE as the Assignee of the entire right, title and interest in and to the same, for its sole use and behoof; and for the use and behoof of its successors, assigns, nominees, or other legal representatives, to the full end of the term for which said Letters Design Patent may be granted.
