QUITCLAIM BILL OF SALE

This QUITCLAIM BILL OF SALE (this "Bill of Sale") is made as of this November 06, 2013, by iSense Corporation, an Oregon corporation ("iSense").

WHEREAS, iSense is a wholly owned subsidiary of Bayer HealthCare, LLC, a Delaware limited liability company ("BHC");

WHEREAS, iSense has agreed to assign, transfer, convey, and deliver to BHC all of the tangible and intangible personal property of iSense; and

NOW THEREFORE, in consideration of the foregoing premises, the promises and covenants contained herein and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties do hereby agree as follows:

I. BILL OF SALE

1.1 Grant. iSense hereby assigns, transfers, conveys, and delivers to BHC, for good and valuable consideration received from BHC, all right, title and interest, of iSense in and to all assets and intangible personal property owned or held by iSense (the "Transferred Assets").

II. MISCELLANEOUS

2.1 NO WARRANTIES. EXCEPT AS PROVIDED UNDER THE ASSIGNMENT, ALL TRANSFERRED ASSETS TRANSFERRED HEREBY BY ISENSE TO BHC ARE CONVEYED "AS IS, WHERE IS" AND WITHOUT ANY WARRANTIES OF ANY KIND WHATSOEVER, INCLUDING WITHOUT LIMITATION ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.

2.2 Successors and Assigns. This Bill of Sale shall be binding upon and insure to the benefit of the parties hereto, and their respective administrators, transferees, successors and assigns.

2.3 Further Assurances. Each of iSense and BHC will use reasonable efforts, upon the request of the other party, to do, execute, acknowledge, and deliver, or cause to be done, executed, acknowledged, and delivered, all such further acts, assignments, transfers, conveyances, powers of attorney, and assurances. iSense will, at BHC's request, use reasonable efforts to obtain all authorizations or consents that may reasonably be required for the conveyance, transfer, assignment, and delivery to BHC, or to its respective successors and assigns, or for aiding and assisting in collecting or reducing to possession, any or all of the Transferred Assets to be transferred hereunder.
