To Whom it may concern:

Please be advised that Jonathan Lee, a citizen of the United States of America, having an address of P.O. Box 9187, Warner Robins, GA 31095, by virtue of that certain Agreement to Pay Commission on Sale of Patents between Kyung Il Jung and Jonathan Lee dated on or about April 26, 2010, has a contractual right to receive payments based upon the proceeds of any patent based upon or claiming priority to any of PCT/KR2008/007261, PCT/KR2010/000285 or PCT/KR2010/000284, and any continuation, division, renewal or substitute thereof, including, but not limited to, U.S. Serial No. 14/245,943, and as to letters patent, any reissue or re-examination thereof.

AGREEMENT TO PAY COMMISSION ON SALE OF PATENTS

Kyung iL Jung, Party of the First Party (hereinafter referred to as "Jung") and Jonathan Lee, Party of the Second Party (hereinafter referred to as "Lee") hereby agree as follows:

1. **Description of the Patents.** Jung owns three patents concerning the design and construction of bottles. Said patents are known respectively as:

A. PCT-KR 2008/007261;

B. PCT-KR 2010/000285; and

C. PCT-KR 2010/000284.

Copies of certificates of applications of the above-referenced patents are attached hereto and incorporated by reference.

2. **Worldwide Territory Granted to Lee for Sale of Patents.** Jung hereby authorizes Lee to sell the above-referenced patents anywhere in the world. The terms of the sale of any of said patents must be expressly approved by Jung.

3. **Term of Agreement.** This agreement shall be in full force and effect for a period of five (5) years from the date of execution and shall automatically renew at the end of said five-year period for successive one-year periods unless terminated in writing by either Jung or Lee.

4. **Payment of Commission.** Jung shall pay Lee twelve percent (12%) of any initial payments made on the patents in question by a buyer(s). For purposes of construing this agreement, the term "initial payment" expressly means the first payment received by a buyer of any one patent. The first five percent (5%) of royalties paid by any purchaser(s) of the patents shall be paid by such purchaser(s) to Jung. Lee shall receive payment on all royalties paid by any purchaser(s) of the patents which are in excess of five percent (5%).

5. **Governing Law.** This agreement shall be governed and construed in accordance with the laws of the State of Georgia, USA.

6. **Best Efforts.** Lee shall use his best efforts to market and sell the patents.

7. **Termination.** During the initial five (5) years of this agreement, the same shall terminate in one of the following ways:

- A. By mutual agreement of Jung and Lee;
- B. By Lee's failing to use his best efforts to market and sell the patents;
- C. All patents described in Paragraph 1 of this agreement are sold by any party or parties;
- D. By either party's breach of this agreement;
- E. For any conduct by either party which is criminal, fraudulent or of such a nature that the same would subject the non-offending party to public shame, embarrassment and/or contempt due to their association with the offending party.

8. **Termination of Agreement after its First Five Years.** After the first five (5) years of this agreement, either party may terminate this agreement by giving the other at least thirty (30) days' advance written notice of the same. Said written notice shall be sent to the addresses listed below:

Either party may change its official address of notice by giving the other written notification of said change of address during the term of this agreement.

9. **Arbitration.** As between the parties hereto, all questions as to the rights and obligations arising under the terms of the contract, the plans and specifications are subject to arbitration. In case of dispute, either party hereto may make a demand for arbitration by filing such demand in writing with the other. Said demand shall be made in writing via certified mail. One arbitrator may be agreed upon, otherwise there shall be three, one named in writing by each party within ten days after demand is received, and a third chosen by the two appointed. Should either party refuse or neglect to appoint said arbitrator within ten (10) days of receipt of demand or to furnish the arbitrators with any papers or information demanded, he or they are empowered by both parties to proceed ex parte. If there is one arbitrator, his decision shall be binding; if there are three, the decision of any two shall be binding. Such decision shall be a condition precedent to any right of legal action, and wherever permitted by law, it may be filed in Court to carry it into effect. No one shall act as arbitrator who is in any way financially interested in this agreement or in the business affairs of either party to this Contract. Arbitration shall take place in Macon, Georgia. Unless an extension is mutually agreed to in writing by both parties, arbitration shall take place no later than one hundred eighty (180) days from the date written notice of a demand for arbitration is first made by either party.

10. **Entire Agreement.** This document reflects the entire agreement between the parties to this agreement. The same may only be modified in writing when signed by both parties.

11. **Unenforceability of Clause.** If any clause in this agreement is ruled unenforceable by an arbitrator or court of law, the remaining clauses of this agreement shall remain in full force and effect.

12. **Travel and Business Expenses.** Jung shall reimburse Lee for all travel and business expenses incurred by Lee as soon as funds are available.

13. **Loan Payoff.** Jung shall repay all loans granted to him by Lee upon the sale of any patent.

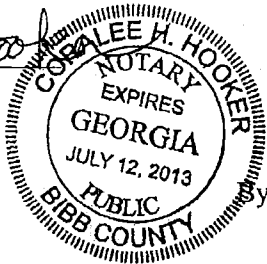
