ASSIGNMENT and TRANSFER OF OWNERSHIP AGREEMENT

In consideration of one U.S. dollar (\$1.00) and other good and valuable consideration, receipt of which is hereby acknowledged, ASSIGNOR hereby sells, assigns and transfers unto said ASSIGNEE, the entire right, title, and interest in and to said IP ASSET and to any United States and foreign patents to be obtained therefor, the same to be held and enjoyed by Assignee for its own use and enjoyment, for the full term or terms for which said intellectual property rights are or may be granted, renewed, or reissued, including all priority rights under any International Convention, and including without limitation any continuation, divisional, continuation-in-part, reissue, re-examination, extensions or foreign equivalents thereof, as fully and entirely as the same would have been held and enjoyed by Assignor, if this Assignment had not been made.


2. ASSIGNOR further covenants that no assignments, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Assignment.

ASSIGNOR further authorizes and requests the Commissioner of Patents and Trademarks to issue any and all Letters Patent referred to above to ASSIGNEE, as the ASSIGNEE of the entire right, title and interest in and to the same, for ASSIGNEE'S sole use and behoof; and for the use and behoof of ASSIGNEE'S legal representatives and successors, to the full end of the term for which such Letters Patents may be granted, as fully and entirely as the same would have been held by ASSIGNOR had this assignment and sale not been made.

4. ASSIGNOR assigns no rights to Assignee other than those transferred hereunder, and Assignor retains any and all right, title and interest to any patents, copyrights or intellectual property of any kind not expressly conveyed herein.
