Assignment

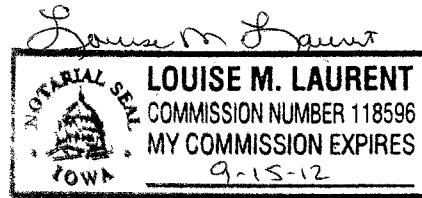
