Now, To All Whom It May Concern: Be it known that for and in consideration of the sum of One Dollar (\$1.00), and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor has sold, assigned, transferred and set over, and does hereby sell, assign, transfer and set over, unto Assignee, its successors, assigns and legal representatives, its entire right, title and interest for the entire world, including the United States, its territories, dependencies and possessions, in and to said Patent Property (and/or patents that may be granted therefrom), and any and all provisional, non-provisional, divisional, continuation, ancestral (e.g., parent), international, foreign, design, confirmation, substitute and reissue application(s) or extensions thereof, as well as any and all applications claiming priority from such applications and any and all applications from which they claim priority; the same to be held and enjoyed by Assignee, its successors, assigns and legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor had this assignment and sale not been made, together with all claims for damages by reason of past infringement of said Patent Property with the right to sue for and collect the same for its own use and for the use of its successors, assigns and legal representatives.

Assignor agrees that this assignment is binding on Assignor and its successors, assigns and legal representatives.

Assignor authorizes and requests the Commissioner of Patents and Trademarks of the United States to issue any Letters Patent of the United States (and the appropriate officer of any relevant foreign country to issue any Patent of such country), resulting from said Patent Property and any confirmations, divisions, continuations, counterparts, reexaminations, reissues or extensions thereof, to Assignee.

Assignor agrees to execute all papers necessary in connection with any interference or post-grant proceeding which may be declared concerning said Patent Property (and/or patents that may be granted therefrom), or any confirmation, division, continuation, reexamination or reissue thereof, and to cooperate with Assignee in every way possible in obtaining evidence and going forward with such interference or post-grant proceeding.


Assignor covenants that it has full right to convey the interest herein assigned and that it has not executed and will not execute any agreement in conflict herewith.
