TERMINATION AND RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY RIGHTS

This TERMINATION AND RELEASE, dated as of December 24, 2014 (this "Termination and Release"), from SIENA LENDING GROUP LLC ("Siena"), as lender under the Loan and Security Agreement, dated as of December 20, 2013 (as amended, supplemented or otherwise modified from time to time, the "Loan Agreement"), between Siena (together with the other lenders from time to time parties thereto, "Lender") and Vinturi, Inc. ("Borrower"), to Borrower.

W I T N E S S E T H:

WHEREAS, pursuant to the Loan Agreement and the other instruments, documents, statements and agreements contemplated thereby or relating thereto, including without limitation the Intellectual Property Supplement to Loan and Security Agreement, dated as of December 20, 2013, by Borrower in favor of Lender (collectively, together with the Loan Agreement, the "Loan Documents") and recorded with the U.S. Patent and Trademark Office on January 8, 2014 at Reel/Frame Nos. 31947/0148 and 5189/0572, Borrower pledged and granted to Lender a continuing security interest (the "Security Interest") in all Intellectual Property of Borrower (such intellectual property, including without limitation the Intellectual Property set forth on Schedule A attached hereto, the "IP Collateral"); and

WHEREAS, Lender now desires to terminate and release the entirety of its Security Interest in the IP Collateral.

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the IP Collateral pursuant to the Loan Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, Lender hereby agrees as follows:


1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Termination and Release, including its preamble and recitals, have the meanings provided in the Loan Documents, as applicable.

2. Release of Security Interest. Without recourse and without representation and warranty, Lender hereby terminates, releases and discharges its Security Interest in the IP Collateral, and any right, title or interest of Lender in the IP Collateral shall hereby cease and become void.

3. Further Assurances. Lender hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts and filings as may be reasonably necessary to effect the release of the Security Interest contemplated hereby, any cost of doing so to be paid by Borrower.

IN WITNESS WHEREOF, the undersigned has executed this Termination and Release by its duly authorized officer as of the date first above written.
