said 50% of the right, title and interest being sold, assigned and transferred to ASSIGNOR from ASSIGNEE being 50% of those rights transferred by virtue of the Assignment from ASSIGNEE to ASSIGNOR recorded at Reel 026367, Frame 0580, so the present Assignment will result in the complete co-ownership by ASSIGNOR and ASSIGNEE of U.S. Patent Application 10/548,507 in the same manner as the co-


