Assignor hereby consents that a copy of this assignment shall be deemed a full legal and formal equivalent of any document which may be required in any country in proof of the right of the Company to apply for patent or other form of protection for said inventions and to claim the aforesaid benefit of the right of priority.


Assignor requests that any and all patents for said inventions be issued to the Company in the United States and in all countries foreign to the United States, or to such nominees as the Company may designate.

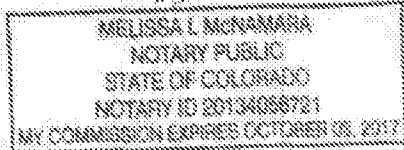

