This ASSIGNMENT OF PATENT ("Assignment") is entered into by and between Estate of Arthur Allen Couch, deceased ("Assignor"), through Kristen M. WHEREAS, on or about June 21, 2005, an invention entitled "Trench Shield Ladder" was patented and issued as United States Patent No. 6,907,957 (the "Assigned Patent"), to Arthur Allen Couch, the sole inventor;

WHEREAS, on the 4th day of December, 2014, the Court in the Probate case authorized this Assignment and authorized Kristen M. Couch, in her capacity as personal representative of the Estate of Arthur Allen Couch, to execute this Assignment on behalf of Assignor;.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor, through Kristen M. Couch in her capacity as personal representative of the Estate of Arthur Allen Couch, hereby assigns, transfers and conveys to Assignee the Assigned Patent, and Assignor's entire right, title and interest in and to the Assigned Patent, including but not limited to the exclusive rights to make, use, offer, sell, rent, import or otherwise exploit any invention patented in the Assigned Patent and the exclusive rights to enforce the Assigned Patent against past, present or future infringement of any invention patented in the Assigned Patent.

Assignor has not previously assigned or otherwise encumbered the Assigned Patent. Notwithstanding any other provision of this Assignment to the contrary, THIS ASSIGNMENT IS MADE WITHOUT ANY REPRESENTATION OR WARRANTY OF ANY NATURE (A) AS TO THE VALUE OR FREEDOM FROM ENCUMBRANCE OF THE ASSIGNED PATENT; (B) AS TO ANY WARRANTY (EXPRESS OR IMPLIED, ORAL OR WRITTEN) OF TITLE, NON-INFRINGEMENT, MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE (WHETHER OR NOT A PARTY OR ITS AFFILIATES KNOWS OR HAS REASON TO KNOW ANY SUCH PURPOSE), OR ANY OTHER MATTER, INCLUDING THE COMPLETENESS OR SUFFICIENCY OF THE ASSIGNED PATENT TRANSFERRED HEREUNDER WHETHER ALLEGED TO ARISE BY LAW, BY REASON OF CUSTOM OR USAGE IN THE TRADE, BY COURSE OF DEALING OR OTHERWISE; OR (C) AS TO THE LEGAL SUFFICIENCY TO GRANT ANY RIGHTS THEREIN.

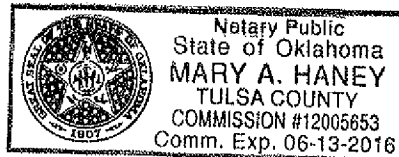
