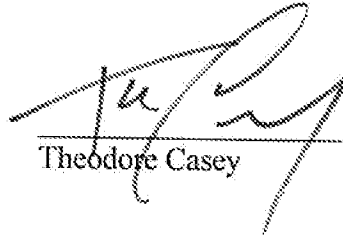
1. Said invention in CONTAINER WITH MIXING BLADE;
