ASSIGNMENT

THEREFORE, Inventor hereby sells, assigns, and transfers unto **MicroZeus, LLC** his full entire right, title, and interest throughout the world in and to said Invention inclusive of any and all priority rights derived therefrom and inventions therein disclosed, and in and to all resulting patents, wherever they may be granted, as well as reissues, continuations, divisions, reexaminations, substitutes or extensions of said patents, domestic and foreign, and the right to claim priority based on the filing date of the above-identified application under the International Convention for the Protection of Industrial Property, the Patent Cooperation Treaty, the European Patent Convention, and all other treaties of like purposes.

Inventor covenants with MicroZeus, LLC that, except for the rights, if any, of the Government, his interest in the rights and property herein conveyed is free and clear of any encumbrance and that he has full right to convey the same as herein expressed. Inventor agrees for himself and his respective heirs, legal representatives and assigns, without further compensation, at the request of MicroZeus, LLC, to make, execute, and delivery to MicroZeus LLC, the Government, or other party prosecuting patent applications on the Invention, any and all papers, documents, affidavits, applications, statements or other instruments relating to said Invention, take all rightful oaths and do all acts as may reasonably be required of them in or incident to the filing or prosecution of any or all applications on said Invention including any and all substitutes, divisions, continuations, reissues or reexaminations, or in the adjustment or settlement of any interferences or other actions or proceedings that said applications or patents thereon may encounter or in which they may become involved.
