ASSIGNMENT OF PATENT

WHEREAS, WE, Saul Griffith, Citizen of Australia, residing at 116 Manchester St., San Francisco, CA 94110; Pete Lynn, Citizen of New Zealand, residing at 4902 Webster St., Oakland, CA 94609; Jake Read, Citizen of Canada, residing at 246 Robert Street Toronto, Ontario, Canada M5S 2K7; Kevin Albert, citizen of the United States, residing at 1930 Grove St. #1, San Francisco, CA 94117; and Tim Swift, Citizen of The United States of America, residing at 2296 Acacia Ave., Clovis, CA 93612, (hereinafter referred to as "ASSIGNORS") have invented and own a certain invention entitled "**DIAPHRAGM COMPRESSOR SYSTEM AND METHOD**", for which application for Letters Patent of the United States of America will be filed on December 19, 2014, and which claims priority to United States Provisional Application 61/918,578, filed December 19, 2013; and

any acts of infringement thereof whether such acts shall have been committed before or after the date of this ASSIGNMENT.


ASSIGNORS hereby covenant that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this ASSIGNMENT;

ASSIGNORS further covenant that ASSIGNEE will, upon its request, be provided promptly with all pertinent facts and documents relating to said application, said invention and said Letters Patent and legal equivalents as may be known and accessible to ASSIGNORS and that ASSIGNORS will testify as to the same in any interference or litigation related thereto and will promptly execute and deliver to ASSIGNEE or its legal representative any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue and enforce said application, said invention and said Letters Patent and said equivalents in the United States or in any foreign country, which may be necessary or desirable to carry out the purposes thereof.


