WHEREAS, We, Chi-Won Choi, resident of Seongnam-si, Gyeonggi-do, Republic of Korea, citizen of Republic of Korea, and Jae-Yong Cho, resident of Anyang-si, Gyeonggi-do, Republic of Korea, citizen of Republic of Korea, have invented certain new and useful improvements in an "METHOD FOR PROVIDING STATUS MESSAGING SERVICE IN ELECTRONIC DEVICE AND THE ELECTRONIC DEVICE THEREOF" disclosed in an application for United States Letters Patent (Application No. _____, filed _____), said application having been executed concurrently herewith;

We hereby further agree that we will communicate to said ASSIGNEE, or to its successors, assigns and legal representatives, any facts known to us respecting any improvements; and, at the expense of said ASSIGNEE, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue and substitute applications, and make all lawful oaths, and generally do everything possible to vest title in said

ASSIGNEE and to aid said ASSIGNEE, its successors, assigns and legal representatives to obtain and enforce proper protection for said invention in all countries.
