Assignor authorizes and requests the Commissioner for Patents of the United States and of all foreign countries to issue any Letters Patent granted for said invention, whether on said

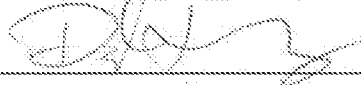

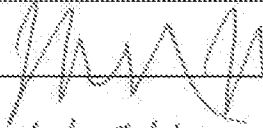
