



CERTIFICATE OF MERGER OF  
DOMESTIC CORPORATION AND  
FOREIGN LIMITED LIABILITY COMPANY

Pursuant to Title 8, Sections 264(c) and 264(e) of the Delaware General Corporation Law, the undersigned corporation executed the following Certificate of Merger:

**FIRST:** That the name of the surviving corporation is CCC Information Services Inc., a Delaware corporation, and the name of the limited liability company being merged into this surviving corporation is Injury Sciences LLC, a Texas limited liability company.

**SECOND:** That a Plan and Agreement of Merger (the "*Agreement of Merger*") has been approved, adopted, certified, executed and acknowledged by the surviving corporation, on behalf of itself pursuant to the applicable provisions of the Delaware General Corporation Law and on behalf of the merging limited liability company pursuant to the applicable provisions of the laws of its jurisdiction of formation.

**THIRD:** That the name of the surviving domestic corporation is CCC Information Services Inc., a Delaware corporation.

**FOURTH:** That the merger shall be effective upon filing and acceptance in both jurisdictions.

**FIFTH:** That the executed Agreement of Merger is on file at the place of business of the surviving domestic corporation, the address of which is 222 Merchandise Mart Plaza, Suite 900, Chicago, Illinois 60654-1005.


