And for the above-named considerations, I, said ASSIGNOR, do hereby agree that I will, at the request of Boston Scientific Scimed, Inc., its successors and assigns, execute any and all applications for Letters Patent for said inventions and any and all other papers and documents and do all other and further lawful acts that Boston Scientific Scimed, Inc. may deem necessary or desirable to obtain Letters Patent on said inventions, to secure the grant of such Letters Patent and to perfect and vest in Boston Scientific Scimed, Inc. the entire right, title and interest in the inventions, applications and Letters Patent.


