**RELEASE AND TERMINATION OF ASSIGNMENT OF SECURITY

FNB further authorizes and requests that the Commissioner of Patents and Trademarks of the United States of America and the empowered officials of all other governments, to note in the record, the termination and release of the security interest heretofore granted by White to FNB with respect to the Patents, Copyrights, Trademarks and Goodwill associated therewith and the Licenses and Proceeds.
