ASSIGNOR (and each of them) further covenants that ASSIGNEE will, upon its request, and without additional consideration required, be provided promptly with all pertinent facts and documents relating to said application(s), said invention, said Letters Patent, and legal equivalents of these in foreign countries as may be known and accessible to ASSIGNOR now or in the future and will testify as to the same in any interference or litigation related thereto, and will promptly execute and deliver to ASSIGNEE or its legal representative any and all papers, instruments or affidavits required or reasonably requested by ASSIGNEE to apply for, obtain, maintain, issue and enforce said application(s), said invention and said Letters Patent and said equivalent or other legal protection thereof in the United States or any foreign country which may be necessary or desirable to carry out the purposes thereof.
