## Background

- A. The Assignor owns the Intellectual Property Rights shown in the Schedule.
- B. The Assignor agreed to assign the Intellectual Property Rights to the Assignee, effective from the Assignment Date.
- C. The Assignor and the Assignee have agreed to sign this Deed to confirm the Assignment.

## Operative Provisions

### 1. Definitions and Interpretation

---

#### 1.1 Definitions

In this Deed unless the context indicates otherwise:-

"Assignment Date" means 1 July 2013.

"Assignment" means the assignment from the Assignor to the Assignee of the rights and causes of action referred to in clause 2 of this Deed.

"Business Day" means a day (other than a Saturday, Sunday, public holiday or bank holiday) on which banks are open for business in Brisbane, Queensland.

"consent" means prior written consent.

"Deed" means this deed and includes the introduction, schedules and annexures to this Deed, and any agreement or deed expressed to be supplemental to this Deed.

"Domain Names" means the relevant licences to use the domain names described in Item 3 of the Schedule.

"Goodwill" for the purposes of this Deed means any goodwill associated with the Trade Marks.

"includes" means includes without limitation.

"Intellectual Property Rights" means all industrial and intellectual property rights throughout the world, whether registered or unregistered, including without limitation

copyright, future copyright, patents, designs, trade marks, domain names, business names, company names, service marks, circuit layout rights, data, know how, trade secrets and all applications and rights in relation to registration of such rights, whether created before, on or after the date of this Deed.

“Patents” means the registered patents and unregistered patents described in Item 1 of the Schedule.

“Schedule” means the Schedule to this Deed.

“Trade Marks” means the registered trade marks and unregistered trade marks described in Item 2 of the Schedule.

## 1.2 Interpretation

In this Deed unless stated otherwise or the context indicates otherwise:-

- (a) Headings are for convenience and do not affect interpretation.
- (b) References to legislation or regulations include any modification or re-enactment of them, and any instrument, regulations or orders issued under them.
- (c) The singular includes the plural and the plural includes the singular. Words importing a gender include every other gender.
- (d) A provision given by more than one person or Party binds them jointly and severally. A provision in favour of more than one person or Party is for their joint and several benefit. A reference to more than one person or Party is to all or any of those persons or Parties.
- (e) A reference to a thing includes the whole or any part of that thing.
- (f) If a word or phrase is defined, its other grammatical forms have a corresponding meaning.
- (g) A covenant not to do anything includes an obligation not to permit that thing to be done, and to use reasonable endeavours to prevent that thing being done by a third party.
- (h) Reference to a “Party” is to a party to this Deed, and includes that Party’s executors, administrators, successors (including any entity resulting from a permitted amalgamation), permitted assigns and substitutes.
- (i) Reference to a “person” or a word denoting an individual, person, firm, partnership, association (whether or not incorporated), corporation, authority, government, government agency or any other body or entity (in each case whether or not having separate legal personality), includes any of them.
- (j) Reference to a month or year is to a calendar month or year.
- (k) Where this Deed requires anything to be done or any time period expires on a day which is not a Business Day, then the thing may be done on and the time period is extended until the next Business Day.



- (l) A reference to any agreement or document is to that agreement or document as amended or replaced from time to time.
- (m) One clause does not limit the effect of another.

## **2. Assignment**

---

- (a) The Assignor and the Assignee confirm that, effective from the Assignment Date, the Assignor has assigned to the Assignee:-
  - (i) all of its Intellectual Property Rights including, without limitation:
    - (A) the Trade Marks, including any Goodwill (if any); and
    - (B) the Patents;
  - (ii) all of its Intellectual Property Rights created on or after the Assignment Date (including on or after the date of this Deed);
  - (iii) all rights and causes of action accrued or accruing with respect to the Assignor's Intellectual Property Rights, including without limitation with respect to:
    - (A) the Trade Marks;
    - (B) the Patents;
    - (C) the Assignor's know how, trade secrets and confidential information (including for breach of confidence); and
    - (D) copyright assigned to the Assignee in accordance with this Deed.
- (b) The Assignor will immediately sign all documents and do all other things requested by the Assignee from time to time to:
  - (i) give effect to this clause or the Assignment;
  - (ii) to register or perfect the Assignee's ownership of any Intellectual Property Rights; or
  - (iii) transfer registration of the Domain Names to the Assignee.

## **3. Power of attorney**

---

The Assignor irrevocably appoints the Assignee as its attorney, for the purpose of signing all documents and doing all other things required to be done by the Assignor under this Deed, or to give effect to the transactions contemplated by this Deed.

## **4. General**

---

### **4.1 Further assurances**

Each Party must do everything reasonably required by the other to give effect to any of the transactions contemplated by this Deed.

### **4.2 Relationship**

Nothing in this Deed constitutes one Party the employee, partner, agent, representative, trustee or joint venturer of the other.

### **4.3 Entire agreement**

This Deed sets out the entire agreement between the Parties and supersedes any prior agreements or discussions.

### **4.4 Counterparts**

This Deed may be executed in any number of counterparts (including facsimile counterparts). Each counterpart is deemed an original and all the counterparts together constitute one instrument, which is deemed to be dated on the date the last Party signs.

### **4.5 Variation**

Any variation to this Deed must be in writing and signed by all Parties to be effective.

### **4.6 No waiver**

None of the following constitute a waiver or variation of a Party's right to demand exact compliance by the other Party with that Party's obligations under this Deed:-

- (a) failure or delay by a Party to exercise any of that Party's rights under this Deed;
- (b) failure or delay by a Party to insist on exact compliance by the other Party with that other Party's obligations under this Deed;
- (c) any practice of the Parties at variance with this Deed; and
- (d) a waiver by a Party of a particular breach does not affect that Party's rights in respect of any preceding, subsequent or other breach.

### **4.7 Severability**

Any provision of this Deed which is illegal, void or unenforceable in a jurisdiction will, as to that jurisdiction, be ineffective to the extent of the illegality, voidability or unenforceability, but without invalidating the remaining provisions of this Deed or affecting the validity or enforceability of that provision in another jurisdiction.

### **4.8 Costs**

Each Party must pay their own costs of and incidental to the preparation and execution of this Deed.



**4.9 No merger**

The Parties' rights and obligations under this Deed will not merge on completion of any transaction.

**4.10 Governing law**

This Deed is governed by Queensland law. The Parties submit to the non-exclusive jurisdiction of the courts of that State.
