For the consideration aforesaid, I hereby covenant and agree to and with the said Assignee, her successors and assigns that whenever her counsel or representative, or the counsel or representative of her successors or assigns, shall advise that formal application papers must be executed or an amendment to, or a division of, or any other proceeding or action in connection with said application(s) or Inventions, including interference proceedings, is lawful and desirable, or that a reexamination, reissue or continuation, continuation-in-part or extension of said Letters Patent is lawful and desirable, I will sign all papers and drawings, take all rightful oaths and affidavits, and do all acts necessary or required to be done for the reexamination, reissue or continuation, continuation-in-part or extension of same, and will do all acts necessary or required to secure to the said Assignee, her successors and assigns, the title to and full benefit of the 50% rights hereby assigned, without charge to said Assignee or her successors or assigns.

AND the Commissioner of Patents and Trademarks is requested to issue the said Letters Patent, when granted, in accordance with this confirmatory sale and assignment.
