ASSIGNMENT

ELECTRIC PUMP

when called upon to do so by the said ASSIGNEES, its successors or assigns, and that I will, at the cost and expense of the said ASSIGNEES fully assist and cooperate in all matters in connection with the United States and foreign applications and patents issuing thereon.
