**ASSIGNMENT**

WHEREAS, James Potter, hereinafter called the "Assignor", has made the invention described in the United States patent application entitled SPLIT AXIS TRANSMISSION HYBRID SYSTEM ARCHITECTURE, for a full description of which reference is here made to an application for Letters Patent of the United States filed on June 3, 2014 and assigned Application Serial No. 14/294,415;

The Assignor hereby sells, assigns, and transfers the entire right, title and interest to the Assignee as of the day of filing the application identified above.
