ASSIGNMENT

THIS ASSIGNMENT is entered into by Quartzdyne, Inc., a corporation of the state of Delaware, having a place of business at 4334 West Links Drive, Salt Lake City, Utah 84120 (hereinafter "Assignor"), to and in favor of Delaware Capital Formation, Inc., a corporation of the state of Delaware having a place of business at 501 Silverside Road, Suite 5, Wilmington, Delaware 19809 (hereinafter "Assignee").

Whereas Assignor previously received the entire right, title and interest in and to the invention described in the application for United States Letters Patent entitled, **"ISOLATION ELEMENTS INCLUDING ONE OR MORE DIAPHRAGMS, SENSORS INCLUDING ISOLATION ELEMENTS, AND RELATED METHODS,"** assigned Serial No. 13/023,339 and filed on February 8, 2011, by Assignment from the inventors, Scott J. Brown, Diana R. Clark, K. Robert Harker, and Lon J. Perry, to Assignor, recorded in the United States Patent and Trademark Office on February 25, 2011, at Reel 025868, Frame 0938, which patent application issued as U.S. Patent 8,333,117 on December 18, 2012 (hereinafter "the Patent"); and

Whereas Assignor desires to assign its entire right, title and interest in and to the Patent to Assignee for valuable consideration; and

Whereas Assignee desires to receive the entire right, title and interest in and to the Patent from Assignor, and to provide such valuable consideration to Assignor;

Accordingly, the parties agree as follows:

1. Assignor hereby conveys and assigns to Assignee, and Assignee accepts, Assignor's entire right, title and interest in and to the Patent and the inventions disclosed therein, including all continuation, continuation-in-part and divisional applications and all continuing prosecution applications based in whole or in part on the Patent or on which the Patent is based in whole or in part, and including all patents, as well as reexaminations and reissues thereof resulting from the Patent.

2. Assignor hereby assigns to Assignee, and assignee accepts, Assignor's entire right, title and interest in and to all counterparts to the Patent that have been or may be filed outside the United States, whether pursued as a patent, an inventor's certificate, a utility model or the like, including all rights of priority based on the Patent, further including all continuation, continuation-in-part and division applications and all continuing prosecution applications based in whole or in part on the non-U.S. counterparts, and still further including all patents, inventor's certificates, utility models and reissues based upon or resulting from any of the non-U.S. counterparts.

3. Assignor hereby grants to Assignee, and Assignee accepts, the sole and exclusive right to prosecute (such term including filing of a patent application) and defend the Patent and all related patents and applications as described in Paragraphs 1 and 2 above, including without

limitation any opposition proceedings, reissue applications, reexaminations, and nullity or invalidity proceedings. Assignor authorizes all governmental bodies having the power to issue patents, reissues, inventor's certificates or utility models to issue a patent, reissue, inventor's certificate or utility model based on the Patent or any related applications as described in Paragraphs 1 and 2 above in the name of Assignee.

4. Assignor agrees upon request and without further consideration, but at Assignee's expense: (a) to assist Assignee in prosecuting the Patent and all related applications as described in Paragraphs 1 through 3 above, as well as opposition proceedings, reissue applications, reexaminations, and nullity or invalidity proceedings, (b) to provide Assignee with information concerning the Patent to enable Assignee to obtain, secure and protect the rights granted under this Assignment; (c) to sign papers, take oaths and testify in legal proceedings to enable Assignee to obtain, secure and protect the rights granted under this Assignment; and (d) to perform all acts reasonable necessary to enable Assignee to obtain, secure and protect the rights granted under this Assignment.

5. Assignor agrees to assign, transfer and set over to Assignee, free and clear of any claims, liens and encumbrances, all of its right, title and interest, legal and equitable, in and to any claims, causes of action for past, present and future infringements of the Patent and any related claims Assignor may have against any third parties, whether known or unknown, and to apply any damages recovered to the account of Assignee.

6. Assignor warrants and covenants that no assignment, grant, mortgage, license or other agreement or encumbrance affecting the rights and property herein conveyed has been or will be made or entered into by the Assignor, and that the full right to convey the same as herein expressed is possessed by the Assignor.

7. Assignor agrees and acknowledges that the sale, assignment and transfer of rights and property set forth herein is and shall be irrevocable and binding upon the assigns, representatives and successors of the undersigned Assignor and extend to the successors, assigns and nominees of the Assignee.

8. Assignee may assign the rights granted to it under this Assignment in whole or in part. All references herein to Assignee include any successors, assigns, or nominees of Assignee.

9. Assignor acknowledges that Assignee has provided, and Assignor has received, valuable consideration sufficient and adequate for the rights granted to Assignee under this Assignment.

10. This Assignment shall be effective upon execution by the authorized representatives of Assignor and Assignee, and the parties hereto agree that a true photocopy if this Assignment shall serve as evidence of same.


