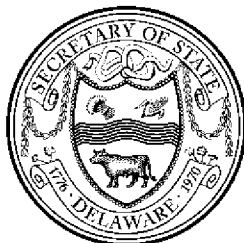

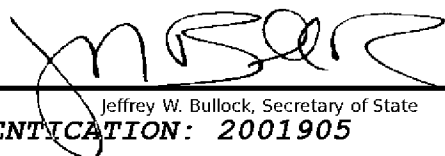

FIRST: That, pursuant to a written consent of the Board of Directors of the Corporation in accordance with Section 141 of the General Corporation Law of the State of Delaware, resolutions were duly adopted setting forth a proposed amendment to the Certificate of Incorporation of the Corporation, as amended, declaring said amendment to be advisable and submitting such amendment to the sole stockholder of the Corporation for consideration thereof. The resolution setting forth the proposed amendment is as follows:

RESOLVED, that, subject to the approval of the sole stockholder of the Corporation, the Certificate of Incorporation of the Corporation shall be amended by changing the Article thereof numbered "FIRST" so that, as amended, said Article shall be and read as follows:

"FIRST: The name of the Corporation is Veolia Water Technologies, Inc."

SECOND: That thereafter, the sole stockholder of the Corporation duly authorized, adopted and approved the amendment described above by written consent in accordance with Section 228 of the General Corporation Law of the State of Delaware.

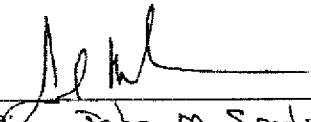
THIRD: That said amendment was duly adopted in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware.
