(2) The Assignor and the Assignee are associated companies and for the better regulation of the affairs of the Assignor and the Assignee it has been previously agreed that all legal rights in the said inventions and any patent applications in respect thereof shall be assigned to the Assignee for the consideration and upon the terms as hereinafter appear

- (1) IN pursuance of the said agreement the Assignor as beneficial owner hereby transfers as a gift with full title guarantee unto the Assignee;
 - (i) the whole of the legal ownership of the property in the Inventions and all such rights including the right to claim priority therefrom;
 - (ii) the right to apply for and obtain a patent or other forms of protection in respect of the Inventions in the United Kingdom and throughout the world (including the right to make a further application in respect of any part or parts of the matter contained in any earlier application);
 - (iii) any existing or future applications for patents or other forms of protection in any part of the world made in respect of the Inventions and all rights in or under such applications;
 - (iv) any patents or other forms of protection whenever granted in respect of the Inventions in any part of the world together with the right to bring proceedings for any previous infringement or for any previous act.
- (2) THIS Deed may be executed/acknowledged in counterparts and by each of the parties on separate counterparts each of which when executed and delivered shall be deemed to be an original and both counterparts together shall constitute one and the same Deed.
- (3) THIS Deed shall be governed by and interpreted in accordance with English law.
