ASSIGNOR further agrees, without any payment by the Assignee, to communicate to the Assignee, its successors, legal representatives and assigns, any facts relating to the Patents and to testify in any legal proceeding, sign all documents, execute all divisional, continuing, and reissue applications, make all rightful oaths, and generally do everything reasonably possible to aid the Assignee, its successors, legal representatives and assigns, to obtain and enforce proper protection for the Patents.

ASSIGNOR hereby authorizes the United States Patent and Trademark Office, the Canadian Intellectual Property Office, and the empowered officials of all other governments to issue or transfer all said Patents to Assignee, as assignee thereof, or otherwise as Assignee may direct.




