This Agreement and Assignment supersedes all other assignments, agreements and addenda related to the above identified application.

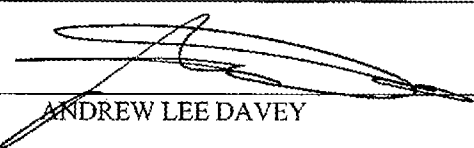
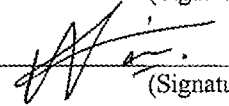
