1. 3. 4. application documents including petitions, specifications, and oaths, and all assignments, disclaimers, and lawful affidavits inform and substance as may be requested by Assignee, to communicate to Assignee all facts known to us relating to said inventions and discoveries or the history thereof; to furnish to Assignee with any and all documents, photographs, models, samples, and other physical exhibits in our control or in the control of our heirs, legal representatives, or assigns which may be useful for establishing the facts of our conception, disclosure, and reduction to practice of said inventions and discoveries; and to testify to the same in any interference, arbitration, or litigation.
