## ASSIGNMENT

THIS ASSIGNMENT, by Steven Douglas Roark and Gina Nance (hereinafter referred to as the Assignors), witnesses:

WHEREAS, said Assignors have invented certain new and useful improvements, which are described in United States patent application 14/616,529 entitled Kiln Baghouse with Dynamically Selectable and Reconfigurable Polishing and Non-Polishing Operations and filed February 6, 2015;
