WHEREAS, Mark Franklin Davis a resident of Pacifica, California, herein referred to as ASSIGNOR, is an inventor and owner of the United States Patent Application Serial No. 11/888,657 filed July 31, 2007, entitled MULTICHANNEL AUDIO CODING.
